

# TOURNAMENT RULES

1. The tournament will be conducted by the Bass Tournament Committee of the St. Clair County Sheriff's Office.
2. Tournament hours will be from safe daylight to 3:00 pm (First Flight). All contestants and boats must depart from the launch site and must return by boat to that landing no later than the end-of-tournament time. Any contestant's boat returning after the end-of-tournament time will be disqualified. There will be no excuses accepted for being late.
3. Rules will be read prior to the tournament start. One partner from each boat must be present.
4. All fish brought to the weigh-in (except trophy bass) will be returned to the water after weigh-in. There will be a 5 fish limit per boat. Contestants MUST use tournament furnished weigh-in bags.
5. The Tournament Committee reserves the right to disqualify questionable fish (iced, damaged, etc.).
6. Only largemouth, smallmouth and spotted bass will be weighed - A one pound penalty will be assessed for each and every fish measuring less than 12 inches. An 8 ounce penalty will be assessed for each and any fish delivered to weigh station dead. A one pound penalty will be assessed for each and every minute that a contestant is late in returning. These penalties will reduce the total weight of the contestant's catch.
7. No alcoholic beverages will be allowed in the boat or at the weigh-in site during the tournament.
8. No trolling, live bait or fishing within 50 yards of another tournament boat. Good sportsmanship is expected at all times. Any disorderly conduct will be ample reason for a contestant's disqualification from the tournament.
9. Contestants will wear a life jacket and will have a kill switch (when main motor is so equipped) attached to person or driver whenever the main motor is running.
10. All live wells and boats will be inspected prior to the start of the tournament. A LIVEWELL CHECK VERIFICATION STICKER will be issued to each boat and that sticker must be affixed to your ENTRY NUMBER CARD before your fish can be weighed.
11. Contestants will abide by all Alabama water safety standards.
12. Single fisherman are allowed.
13. NO HOLE SITTING
14. It will be an expressed condition that all prize winners be subject to a polygraph test by a licensed polygraph tester, and must pass the test in order to win the prize.
15. I understand that officials of this event have the right to postpone this event due to weather or other safety related considerations.

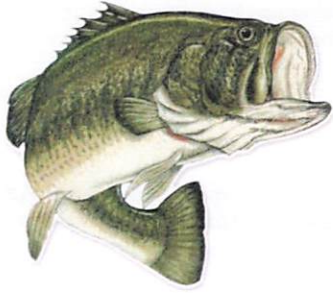
